SETTLEMENT STIPULATION

The State of Florida, Office of Financial Regulation ("Office") and Circle K Stores, Inc.

("Circle K"), in consideration of the mutual promises herein, recite, stipulate, and agree as follows:

1. Background. An Administrative Complaint and Notice of Intent to Issue Cease &

Desist Final Order ("Administrative Complaint") was issued against Circle K on January 31, 2014,

wherein it was alleged that around mid-June 2013 Circle K was cashing payment instruments

without a license. The Administrative Complaint had attached a Notice of Rights which, pursuant to

Ch. 120, Florida Statutes, afforded Circle K the opportunity to challenge some or all matters raised

therein.

2. A response requesting a formal administrative hearing was timely received on February

10, 2014, with a request that the response/petition not be referred to the Division of Administrative

Hearings, pending a mutually agreeable settlement of all outstanding issues.

3. On June 30, 2014, the Office issued an Amended Administrative Complaint and Notice

of Intent to Issue Cease & Desist Final Order ("Amended Administrative Complaint") alleging,

among other things, that between January 1, 2009 and February 14, 2014, Circle K was cashing

payment instruments without a license. A Notice of Rights was also attached to the Amended

Case No. 0977-M001/14 Settlement Stipulation Page 1 of 7 Administrative Complaint and again Circle K timely requested a formal administrative hearing with

the same request.

4. At all times material herein, Circle K was operating convenience stores in Florida.

5. The Office's records show that Circle K cashed checks between January 1, 2009, and

February 14, 2014.

6. The Office's records also show that at no time between January 1, 2009 and February 14.

2014 was Circle K licensed to transact business as a money services business pursuant to Chapter

560, Florida Statutes.

7. Circle K is not currently licensed to transact business as a money services business

pursuant to Chapter 560, Florida Statutes. However, Circle K has submitted, and the Office has

deemed complete, an application for a Part III Money Services Business license. The Office has

determined that the application meets the requirements for approval.

8. Jurisdiction. Pursuant to section 560.105, Florida Statutes, the Office is charged with

administering and enforcing the provisions of Chapter 560, Florida Statutes, and therefore has

jurisdiction to bring this administrative action against Circle K pursuant to Chapter 560, Florida

Statutes.

9. Findings. For purposes of this Stipulation, Circle K neither admits nor denies that it

violated any provisions of Chapter 560, Florida Statutes. Pursuant to Section 560.114(1)(a), Florida

Statutes, a failure to comply with any of the provisions of Chapter 560, Florida Statutes, or related

rule or order, constitutes grounds for disciplinary action.

10. Terms and Conditions. Circle K and the Office agree that the issues raised in the

Amended Administrative Complaint can be expeditiously resolved without litigation or further

expense to either party, by the execution of this Settlement Stipulation. The parties acknowledge

Case No. 0977-M001/14 Settlement Stipulation Page 2 of 7 they have read this Settlement Stipulation and fully understand the rights, obligations, terms, duties

and responsibilities with respect to its contents. Therefore, in compromise and settlement of the

foregoing findings, Circle K and the Office agree to the following terms and conditions:

a) ADMINISTRATIVE FINE. An executed copy of this Settlement Stipulation

shall be hand delivered by Circle K to: Agency Clerk, Office of Financial Regulation, The Fletcher

Building, Suite 118, 101 East Gaines Street, Tallahassee, Florida 32314-8050. Upon execution of

the Settlement Stipulation by both parties, a Final Order adopting the terms of such Settlement

Stipulation shall be entered by the Office. Within three (3) days of the entry of the Final Order, Circle

K shall pay an administrative fine in the amount of One Million Dollars (\$1,000,000.00) to the Office

of Financial Regulation, in the form of a bank wire transfer to the **Department of Financial** 

**Services.** The Office shall provide Circle K with appropriate wire transfer instructions to allow

Circle K to effect this payment in a timely manner.

b) Upon the timely receipt by the Office of the full payment of the administrative

fine agreed to herein, the Office shall within one (1) business day issue to Circle K a Part III Money

Services Business license.

11. **Final Order.** Circle K consents to the issuance of a Final Order which incorporates the

terms of this Settlement Stipulation. Circle K understands and agrees that this Settlement Stipulation

is subject to the final approval of the Commissioner of the Office of Financial Regulation and the

entry of the Final Order adopting such Settlement Stipulation. In the event that the Final Order is not

entered, this Settlement Stipulation shall be null and void. The Final Order incorporating this

Settlement Stipulation constitutes final agency action by the Office for which the Office may seek

enforcement pursuant to the provisions of Chapters 560 and 120, Florida Statutes.

12. Waiver. By Circle K's consent to the entry of a Final Order with respect to this matter,

Circle K waives:

a) Any right to separately stated Findings of Fact and Conclusions of Law;

b) Any right to receive a Notice of Rights pursuant to Chapter 120, Florida Statutes;

c) Any right to an administrative hearing or issuance of a Recommended Order pursuant

to Chapter 120, Florida Statutes;

d) Any right to contest in any administrative forum or judicial proceeding (including,

but not limited to, an appeal pursuant to section 120.68, Florida Statutes) the validity

of any term, condition, obligation, or duty expressly created in this Stipulation and the

Final Order.

13. Releases. Upon full execution of this Settlement Stipulation, entry of the Final Order,

and issuance of the Part III Money Services Business license, Circle K waives, releases and forever

discharges the Office and its agents, representatives and employees from any and all causes of action,

in law or in equity, which Circle K may have arising out of this matter. The Office accepts this

release and waiver by Circle K on behalf of itself, its agents, representatives, and employees without

acknowledging, and expressly denying, that any such right or cause of action may exist. Upon full

execution of the Settlement Stipulation, entry of the Final Order, and payment of the total

administrative fine agreed to in Paragraph 10.b., the Office waives, releases and forever discharges

Circle K and its directors, officers, employees, and agents from each and every cause of action which

the Office may have arising out of the conduct of Circle K as alleged in the Administrative

Complaint and the Amended Administrative Complaint.

14. Failure to Comply. Circle K acknowledges, concurs, and stipulates that Circle K's

failure to comply with any of the terms, obligations and conditions of this Settlement Stipulation, and

the Final Order adopting it, is a violation of the stipulation and the Final Order entered pursuant to

Chapters 120 and 560, Florida Statutes. Such non-compliance may result in the issuance of an

emergency cease and desist order. However, nothing herein shall be construed to limit Circle K's

rights to contest any finding or determination of non-compliance.

15. Attorney's Fees. Each party herein shall bear its own costs and attorneys' fees incurred

in the prosecution, defense, or negotiations in this matter up to and including entry of the Final Order

adopting this Settlement Stipulation.

16. Counterparts. This Settlement Stipulation may be executed in any number of

counterparts, and by the parties in separate counterparts, each of which will be deemed to be an

original but all of which together will constitute but one Settlement Stipulation.

WHEREFORE, in consideration of the foregoing, the Office and Circle K execute this

Settlement Stipulation for issuance of a Final Order, as attached hereto, on the last date executed

below.
