





Tenant Additional Partnership Services

St. Louis Community Credit Union

A partnership with Ballpark Village / SLATE / St. Louis Community Credit Union was formed to address the payroll issue of new hires not having bank accounts to do direct deposits. The relationship has grown beyond the initial purpose. The SLCCU attends the monthly new hire orientation to help new employees open accounts to do direct deposit. Ballpark Village has hosted two "Bank Days" when SLCCU will come in for a day to provide information about their services to their employees.

As of today, 94 accounts have been open, of those 50% are in Credit Counseling with the bank to help build their credit. 16 have purchased life insurance and supplement insurance. 15 have already purchased cars.

This partnership is helping Ballpark Village employees get back into banking, learn about insurance options, get help with auto loans and credit counseling.
