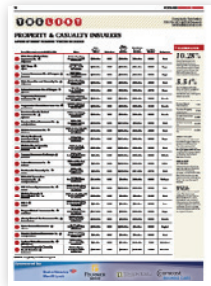
### CENTERPIECE

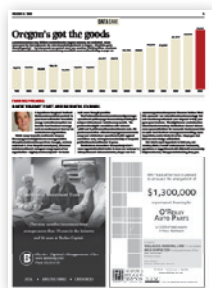
### THE LIST
