I currently work as a Registered Nurse and student obtaining my Master's Degree to become a nurse practitioner. My brother is not by any means a perfect person, however, I do believe he is capable of change and can be a valuable asset to society despite his transgressions, to which I believe is a direct result of unresolved issues surrounding the death of our mother at a young age. I say this because even I have a hard time coping with her loss, however, I transfer my energy into my career. Unfortunately, Kashamba being the youngest, was not able to find a healthy way to cope and put that energy into Gambling, which led to other things, I myself am not happy with him about. However, I am able to see the good that my parents has groomed within us. I have watched Kashamba as a father and he was an exceptional one at that. He focused on his son's education, taking him to the library daily to read as an infant, when the rest of the family criticized how his son at was too young to understand what was going on. However, before the age of one his son was able to identify his shapes, colors, and recognize sight words. This I believe was a direct result of Kashamba pouring into him. To this day, his son is advanced in school and able to articulate himself beyond what one expects for a child his age. I have a one-and-a-half-year-old son now and because of Kashamba, I did the very thing I chuckled about, with my son, and I am amazed at how intelligent he is.

Kashamba has impulsive issues at times but he loves and cares for others as well, especially children. In the neighborhood, on Sundays, he would buy a variety of snacks and have the neighborhood kids come outside to play baseball. They enjoyed and looked forward to "KJ" coming.
