To Whom it may concern:

This notice is being provided to you pursuant to the Federal Worker Adjustment and Retraining Notification Act. Del Taco LLC ("Del Taco") is providing this notice to you because it is closing a number of its locations in the State of Texas, which could be deemed a "mass layoff" under the Federal WARN Act. Del Taco has made this decision for financial reasons. It is anticipated that, as of December 15, 2015, a total of 213 employees will be laid off at the following locations:
